## REMINDER

**SUBJECT: Suspension of applications for apprenticeship**

**DATE: August 2, 2010**

This memo serves as advanced notice that the Joint Apprenticeship Committee for the Construction Craft Laborers' Apprenticeship Program will suspend accepting applications for apprenticeship during the months of **September, October, November and December 2010, and January February, March, April and May 2011. At this point the JAC intends to resume accepting applications June 1, 2011.**

The Committee has regretfully made this decision due to:

- unprecedented levels of unemployment within the industry;
- excessive surplus of persons that have applied and qualified for apprenticeship, but are unable to find a sponsoring contractor.

**Beginning September 1, 2010**, contractors wishing to employ an apprentice and or contractors already employing apprentices, and eligible to employ additional apprentices, must contact the local union office in their area for a referral of registered apprentices who are currently unemployed. *(A listing of local union offices, contact persons and telephone numbers is included with this notice.)*

Contractors may also contact the Apprenticeship Office for a listing of persons from their area who have met eligibility requirements, but have been unable to find a sponsoring contractor.
